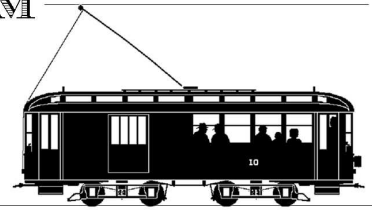

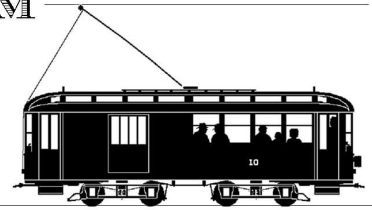

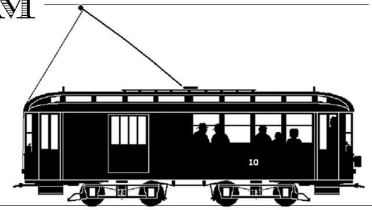

SPEED RESTRICTIONS - TRACK

No equipment may exceed a fast walking speed over the frog of Turnout 1 in either direction.

No equipment may exceed a fast walking speed over the frog of Turnout 2 in either direction.

No trolley car or Trackmobile may exceed a fast walking speed on the House Track in either direction.

No equipment may exceed a slow walking speed over Turnout 5 in either direction.

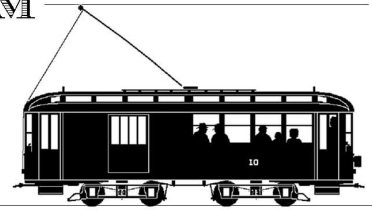
No equipment may exceed a slow walking speed over Turnout 7 in either direction.

RULE CHANGE – MINIMUM AGE

In your Rulebook change “16” to “15” in Rules 6 and 7 so that they read:

*6. A qualified Motorman must be at least **15** years of age. Any Motorman under 21 years of age must be working with a Conductor over 21 years of age.*

*7. A qualified Conductor must be at least **15** years of age. Any Conductor under 21 years of age must be working with a Motorman over 21 years of age*
